

SUMMARY ANNUAL REPORT FOR THE Y.A.L.E. SCHOOL'S HEALTH AND WELFARE BENEFITS PROGRAM

This is a summary of the annual report of the Y. A. L. E. School's Health and Welfare Benefits Program, Plan Number 501, Employer Identification Number 22-2120871, for the plan year period beginning January 1, 2025 and ending December 31, 2025. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

UNINSURED COMPONENTS

The plan sponsor, Y. A. L. E. School Inc., has committed itself to pay certain healthcare flexible spending account claims under the terms of the plan.

INSURED COMPONENTS - INSURANCE INFORMATION

The plan had contracts with insurance carriers to pay certain claims incurred under the terms of the plan. The type of benefit provided, name of the insurer, and premiums paid for each component are set forth in the table below. The total amount of premiums paid for contract years that ended during the 2025 plan year were \$5,873,244.
